INSTRUCTIONS

- 1. A Member desiring to exercise his/her vote by postal ballot should complete this Postal Ballot Form (in original as no other form or photo copy thereof is permitted to be used for the purpose) and send it to the Scrutinizer in the enclosed self-addressed, postage pre-paid envelope. However, envelopes containing postal ballot form, if sent by courier/registered post to the address of the Scrutinizer at the expense of the Member, will also be accepted.
- The consent of the Member must be accorded by recording the assent in the column 'FOR' and dissent in the column 'AGAINST' by
 placing in a tick mark (√) in the appropriate column. The assent or dissent received in any other manner shall not be considered valid.
- 3. The Postal Ballot Form should be completed and signed by the Member. In case of joint holding, this Form should be completed and signed (as per specimen signature registered with the Bank's share department/ Depository Participant) by the first named Member and in his/her absence, by the next named Member.
- 4. The right of voting by Postal Ballot shall not be exercised by a Proxy.
- 5. An unsigned or incorrect Postal Ballot Form will be rejected.
- 6. Where the Postal Ballot Form has been signed by an authorised representative of a body corporate, a certified copy of the relevant authorisation to vote on the Postal Ballot should accompany the Postal Ballot Form. Where the form has been signed by the representative of the President of India or from the Governor of the State, a certified copy of the nomination should accompany the Postal Ballot Form. A Member may sign the form through an Attorney appointed specifically for this purpose, in which case an attested true copy of the Power of Attorney should be attached to the Postal Ballot.
- 7. The postage pre-paid self-addressed envelope bears the name of the Scrutinizer appointed by the Board of Directors of the Company. The duly completed Postal Ballot Forms should reach the Scrutinizer not later than the close of working hours on June 3, 2018. Postal Ballot Forms received after this date shall be strictly treated as if the reply from the Member has not been received.
- 8. The Scrutinizer's decision on the validity of a Postal Ballot Form will be final and binding.
- 9. Voting Rights shall be reckoned on the paid up value of shares registered in the name of Members as on date of dispatch of notice.
- 10. A Member may request for a duplicate Postal Ballot Form, if so required. However, the duly completed Postal Ballot Form should reach the Scrutinizer not later than the date and time specified herein above.
- 11. A Member neither needs to use all his/her votes nor needs to cast all his/her votes in the same way.
- 12. Members are requested not to send any other paper along with the Postal Ballot Form in the enclosed self-addressed envelope, other than those elucidated in point number 6. If any extraneous papers are found, the same will be destroyed by the Scrutinizer.
- 13. The Company is pleased to offer e-voting facility as an alternate option, for all the Members of the Company to enable them to cast their votes electronically instead of dispatching Postal Ballot Form. E-voting is optional. The detailed procedure is enumerated under Notes of Postal Ballot Notice.
