INDEPENDENT AUDITOR'S REPORT

To the Members of CALCUTTA COMPRESSIONS & LIQUEFACTION ENGINEERING LIMITED

Report on the Audit of Financial Statements

Opinion

We have audited the accompanying financial statements of **CALCUTTA COMPRESSIONS & LIQUEFACTION ENGINEERING LIMITED** ("the Company"), which comprise the Balance Sheet as at March 31, 2025, the Statement of Profit and Loss (including Other Comprehensive Income), the Statement of Cash Flows and the Statement of Changes in Equity for the year ended on that date and a summary of the significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ('Act') in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India including Indian Accounting Standards ('Ind AS') prescribed under section 133 of the Act read with the Companies (Indian Accounting Standards) Rule, 2015, as amended, of the state of affairs (financial position) of the Company as at March 31, 2025, and its profit (financial performance including other comprehensive income), its cash flows and the changes in equity for the year ended on that date.

Basis for Opinion

Emphasis of Matter

We draw attention to Note 28 for change in the method of preparation of the financial statements, which describes that the financial statements have not been prepared on a going concern basis as the management has determined that the company will not continue its operations in the foreseeable future. As a result, the financial statements have been prepared on a net realizable basis. Our opinion is not modified in respect of this matter.

Key Audit Matter

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current period. These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

We have determined that there are no key audit matters to communicate in our report.

Information other than the Financial Statements and Auditor's Report thereon

The Company's Board of Directors is responsible for the other information. Other information does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the standalone financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the standalone financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

Responsibilities of Management for the Financial Statements

The Company's Board of Directors is responsible for the matters stated in section 134(5) of the Act with respect to the preparation of these standalone financial statements that give a true and fair view of the state of affairs (financial position), profit or loss (financial performance including other comprehensive income), changes in equity and cash flows of the Company in accordance with the accounting principles generally accepted in India, including the Ind AS specified under section 133 of the Act. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

Notes to standalone financial statements for the year ended 31 March 2025

Note 1: Significant accounting policies and other explanatory information

A Company information:

Calcutta compressions & liquefaction engineering limited (the 'company') is a company domiciled and incorporated in India. The registered of the Company is situated at Unit No.203, 2nd Floor,52A Shakespeare Sarani, Chandan Niketan, Kolkata, WestBengal-700017 and corporate office: 204, Raheja Centre, Free Press Journal Marg, 214, Nariman Point, Mumbai - 400 021. The Company is engaged in dealing of Coal Based Methane Gas and liquefied petroleum gases. etc.

B. Basis of preparation of financial statements:

These financial statements have been prepared in accordance with the applicable accounting framework as prescribed under the Companies Act, 2013 and relevant Accounting Standards, except for the fundamental accounting assumption of going concern.

The management has assessed the Company's ability to continue as a going concern and has concluded that the going concern assumption is no longer appropriate due to cessation of operations. Accordingly, the financial statements have been prepared on a non-going concern basis.

Under this basis, assets have been stated at their estimated net realisable value and liabilities have been recorded at their estimated settlement amounts. Adjustments have been made where necessary to reflect the intention of the Company to realise assets and discharge liabilities in the normal course of winding down its operations.

C. Use of Estimates:

ii) Liquidity risk

Due to the nature of the business, the Company maintains flexibility in funding by maintaining availability under committed facilities.

Management monitors rolling forecasts of the Company's liquidity position and cash and cash equivalents on the basis of expected cash flows. The Company takes into account the liquidity of the market in which the entity operates. In addition, the Company's liquidity management policy involves projecting cash flows in major currencies and considering the level of liquid assets necessary to meet these, monitoring balance sheet liquidity ratios against internal and external regulatory requirements and maintaining debt financing plans.
