- (i) Any person/party aggrieved by this order, may under section 15 (1) (b) of the Foreign Trade (Development and Regulation) Act, 1992 (Act 22 of 1992) as amended by Foreign Trade (Development & Regulation) Amendment Act, 2010 (Act 25 of 2010) file an appeal against the same to the appropriate Appellate Authority viz. Director General of Foreign Trade, Government of India, Udyog Bhawan, H-Wing, Gate No. 2, Maulana Azad Road, New Delhi 110 011, within a period of 45 days from the date of service of this Adjudication Order together with a copy of this order and complete set of evidence in the form of Annexure to the appeal relied upon in support of the appeal.
- (ii) Any person/party desirous of filing an appeal against this order shall deposit the penalty amount and produce proof of payment of penalty amount along with the appeal to the Appellate Authority failing which the appeal is liable to be rejected for non-compliance of the provisions of Section 15 of the Foreign Trade (Development and Regulation) Act, 1992, as amended from time to time.
- (iii) The penalty amount is to be deposited in an authorized branch of Central Bank of India under the "Head of Account 1453 Foreign Trade & Export Promotion, Minor Head 102 Other Receipts Fine & Penalties etc." The bank receipt must show the Name of Department viz. Development Commissioner, Kandla Special Economic Zone. The bank receipt should be drawn in favour of Regional Pay & Accounts Officer, Mumbai.
- (iv) Evidence of payment of penalty or admission of appeal, if any, filed is required to be furnished to the Adjudicating Authority within 45 days from the date of serving of this Adjudication Order, failing which appropriate recovery proceedings as provided for in the amended Section 11(5) of the Principal Act would be initiated without any further notice and also the I Code Number of this company and other connected liable entities concerned, would be suspended as per the provisions of Section 11(4) of Foreign Trade (Development and Regulation) Act, 1992, without making any further reference to you.

achievement of positive NFEE, I do not find any malafide on the part of the noticee. I therefore hold the Noticee guilty of not achieving the NFE by Rs. 112902.71 Lakhs, which they were under legal obligation to achieve in the five years block period as per the provisions of Rule 53 of the SEZ Rules, 2006. Thus, they have contravened the provisions of Rule 53 of the SEZ Rules, 2006, as well as the condition No. (8) of the Bond-cum-Legal Undertaking executed by them with the Development' Commissioner as discussed herein above. Therefore, they are liable for penal action under Rule 80 of the SEZ Rules, 2006 as amended read with FT (D&R) Act, 1992 as made applicable under Rule 54 of SEZ Rules, 2006 and also under Rule 25 of the SEZ Rules, 2006.

11. Further, as regards the proposed cancellation of LoA under Section 16 of the SEZ Act in the SCN, I find that this provision applies for persistent violations of conditions of LOA by SEZ unit. The cancellation of LOA is major punishment and therefore such punishment requires to be invoked only in cases of grave violation by persistent and habitual offender units. Therefore, in the instant case even though violation is grave in nature, but, principle of natural justice warrants that they may be given another chance. Therefore, as discussed here-in-above, I do not find this case is ripe for taking any action under Section 16 of SEZ Act, 2005 and therefore, proceedings initiated for cancellation of LoA is liable to be dropped. However, the Noticee is warned that any repetition of such contravention in future would render them punishable under the above Section.

With a view to the above discussion and findings, I pass the following order:

ORDER

- i) I uphold the averments made in the SCNs for non-achievement of cumulative positive NFE against M/s. Everest Kanto Cylinder Ltd., Plot No. 525 to 542, 618, 619, 627 & 628, New Area, KASEZ that they have contravened the provisions of Rule 53 of the SEZ Rules, 2006, the Condition no. 8 of the Bond cum Legal Undertaking executed by them with the Development Commissioner.
- ii) I find that the Noticee is entitled to regularize the shortfall in NFEE for the 5 year block period 2020-21 to 2024-25 on payment of an amount of 1% of FOB as provided under Rule 80 of the SEZ Rules, 2006 (as amended). Therefore, I direct the Noticee to deposit an amount of **Rs. 1129.03 Lakhs**

(Rupees Eleven Thousand Twenty Nine Lakhs and Zero Three thousand only) i.e. equivalent to one percent shortfall in the FOB value for the violations of Rule 25 and Rule 54(2) of the SEZ Rules, 2006 and the provisions & conditions stipulated in their Letter of Approval and Bondcum-Legal Undertaking executed with this office.

- iii) I hereby drop the proposed proceedings of cancellation of Letter of Approval under Section 16 of SEZ Act, 2005.
- 12. This is issued without prejudice to any other action that may be taken against the unit under any other Law/Act/Rules in force.
